#### **GENERAL CONDITIONS OF SALE**

#### **BOOKING CONDITIONS:**

The rental shall become effective from receipt of the duly signed booking contract and required down payment, together with acceptance of the General Conditions of Sale. All rentals are specific to the name provided and cannot be transferred or sub-let. Minors must be accompanied by their parents or legal guardians. The management reserves the right to change an assigned number. The basic package provides space for 4-6 people, according to the accommodation type. The campsite reserves the right to refuse access to families whose numbers exceed the capacity of the rented accommodation. Smoking inside accommodation is strictly prohibited.

#### RENTAL:

The stay must be paid in full on the day of arrival (by cheque, 'chèques-vacances' [holiday vouchers], cash or bank card). In the event of a delayed arrival of which we have not been notified, the rental/location shall become available 40 hours after the arrival date specified on the booking contract. After 40 hours have elapsed and where no written notification has been provided, the booking shall be null and void and the campsite management shall retain the down payment. No discounts shall be granted for a delayed arrival or early departure. In the event of a cancellation within 30 days of the arrival date, the campsite management shall retain the down payment.

#### \*Arrival:

The reception is open from 8am to 1pm, and from 3pm to 8pm (High Season), and from 9:30am to 12pm, and from 4pm to 6:30pm (Low Season). Customers may check in from 4pm. A deposit of €150 per lodging is payable on the day of arrival, and shall be reimbursed at the end of the stay during reception opening hours, and after an inventory has been performed. The cost of any damage shall be added to the price of your stay. If you are unable to attend the inventory, your deposit will be returned by post.

# \*Stay:

All customers must comply with the provisions of the internal rules displayed at reception. A copy of these rules shall be provided on request. Each named tenant is responsible for any problems or disturbances caused by those staying with or visiting him/her. Children must be supervised by and remain under the full responsibility of their parents inside the campsite (including the swimming pool). Open fires (wood, coal etc.) and fireworks are strictly prohibited. Pets shall be tolerated on the condition that their full up-to-date vaccination records are provided. They must be kept on a lead inside the campsite, and should never be left alone without supervision in the accommodation. Their owner is responsible for picking up faeces.

### \*Departure:

Accommodation should be vacated before 10am. The rented premises shall then be inspected. If they are completely clean and no equipment is damaged or missing, the deposit shall be reimbursed. Any cleaning not carried out shall be charged on departure at a rate of €50.
